ORGANISATIONAL CHARTER

Article I: Name

KAUST Movement

Article II: PURPOSE

The objectives of the Club are to:

- Promote genres of movement within the KAUST Community.
- Organize events and activities that promote culture and self-expression of participants and community members.
- Ensure an environment emphasizing cooperation, consideration, respect for cultural heritage, mutual encouragement.
- Provide an environment where participants are able to extend upon their current skill levels in movement genres.
- Liaise with KAUST Recreation Services with regards to provision of venues for practice and performance of skills and talents.
- Provide opportunities for the KAUST Community to learn more about expressive genres and disseminate information on matters related to this SDG.
- Develop an understanding of the interest of the KAUST Community in different genres expressive movement and strive to find qualified teachers and interested members of the Community to fulfill this need.

Article III: MEMBERSHIP

The following are eligible for membership of Movement SDG:

All members of the KAUST Community, both employed by KAUST directly or subcontracted but living on site are eligible for membership to the Movement SDG as outlined below:

- KAUST Faculty and staff
- Community members and their eligible dependents

Article IV: OFFICERS

The Movement SDG shall have the following executive officers:

- President
- Vice-President
- Secretary
- Vice-Secretary
- Treasurer

Full Committee:

- Community Liaison Officer
- Event Planner
- Cultural Adviser
- Recreation Liaison Officer
- Membership Officer
- Student Representative from MSHS

Additional Committee Members:

• From each of the genres being taught through the SDG, two people will be responsible for the membership, Code of Conduct, Dress Code, collection of fees and organizing the participant details. These people will automatically become part of the full committee as outlined above.

Article V: MEETINGS

Meetings shall be held for following reasons:

- There will be meetings once a quarter to ensure that the SDG is running smoothly
- Review the movement program offered at KAUST
- Planning lesson schedules for movement classes
- Reviewing credentials for possible teachers for movement classes
- Ensure that communication with the Recreation facility and the KAUST Management is transparent
- Prepare and organize community recitals and performances
- Annual review of the program, funds, policies and procedures of the Movement SDG
- In response to any perceived problems, concerns or written correspondence from community members that cannot be otherwise resolved

Article VI: ELECTIONS

Electing Officers of the Club may be done:

- Annually
- Through ballot
- Members of the Movement SDG who have adhered to the constitution and adhere to the Movement SDG Code of Conduct.

Article VII: AMENDMENTS

- The addition of the new dance genres
- New dance classes must have a Code of Conduct and Dress Code that has been approved by the Full Committee
